From the Executive Director:

As the Executive Director at the Community Foundation for Rockbridge, Bath and Alleghany (CFRBA), it is with great pleasure that I present you with our FY 21-22 Annual Report. This report features the impact that The community foundation, our donors, and partners have had on our region. The stories highlight the importance of your support, and how it enables us to be responsive to all kinds of situations, represent our communities, and channel the real experiences of the people who need our help the most.

It is very humbling and gratifying to see so many individuals make the decision to become part of our CFRBA family of funds. It took our foundation ten years to reach over \$7M in assets. This has allowed us to grant \$3.4M from more than 80 funds to community programs, projects and efforts over the last decade.

This was a remarkable year of transformation and growth for the Community Foundation. We led the effort in Community Projects to increase our grant-making and address needs intensified by the COVID-19 pandemic. We supported black-owned entrepreneurship. We funded programs that allowed every school age family to receive a free holiday meal. We worked with our donors in so many ways to increase their philanthropic impact.

Our Community Foundation was created out of a few funds and the forward thinking generosity of individuals who wanted to make our community better. Over the last decade, we have grown from \$864,000 to total assets to over \$7 million. This didn't happen by chance or luck. The strength of our organization and the community itself lies in generations of generosity.


This year alone, we accomplished big things with the help of our community. We received \$1.2 million in gifts from generous individuals, organizations, and families. We awarded \$286,000 in grants to deserving nonprofit organizations in our service area. We helped individuals pursue their dreams by awarding over \$25,000 in scholarships. We funded the start-up of ten (10) new Black owned businesses.

We recognize that we are part of something bigger than ourselves. The work we do together is built on deep history and dedicated to a brighter future. Thank you for investing in our community, and we look forward to many more generations of positive change

In summary, I want to say "thank you" on behalf of our board members and myself to our fund holders, donors, and advisors for the continued support received. CFRBA will continue to encourage donors to think outside the box, finding new ways to fulfill their passion and impact lives. 

After learning about the Community Foundation, its history, management and expertise as an effective and efficient means to support the community, they decided that a donoradvised fund under their stewardship would be an ideal way to achieve our philanthropic interests.

Through annual financial distributions from the donor-advised fund, they can contribute directly to organizations with charitable interests they support and also make contributions to the Community Foundation, utilizing their administrative and financial management for annual grant programs benefiting local charities in perpetuity.

Before moving to Lexington from Nashville, Rob was Vice President-Development for the Behavioral Health Division of Universal Health Services and was involved in mergers and acquisitions totaling more than \$6 billion, as well as the development of much needed new hospitals, with a total number of behavioral beds in the U.S. exceeding 22,000. Rob has continued to facilitate the sale and acquisition of organizations in this crucial segment of national health care as a consultant. In the community, he serves on the vestry of Grace Episcopal Church and the Annual Funds Council at W&L.

Su's work background includes experience in the fields of museum and hospital public relations and special events coordination and fundraising for independent schools. She is a member of the Board of the Historic Lexington Foundation and the Blue Ridge Garden Club.

When friends ask Rob "why Lexington?" an easy response is why not Lexington? It is a wonderful environment with many opportunities for social, recreational and civic involvement. As an alumnus of Washington & Lee University this area has always held a special place for Rob, and Su feels the same way as a Mary Baldwin graduate. They have been able to support W&L through annual gifts and the establishment of a Charitable Remainder Unified Trust (CRUT). "In the future, we plan to fund one through the Community Foundation to assist us in providing future gifts and bequests."

They know that the Community Foundation can assist them with strategic philanthropy in developing a flexible and functional approach to their philanthropy that will provide more structure for contributions to current and future recipient charitable organizations.

Twelve Days of Donor Appreciation





Walker Program Announces Seven New Business Start-Mp Grants



An automobile repair shop, a photography studio offering classes and events, and an all-natural hair-care product manufacturer are among the seven new start-up businesses

awarded grants through The Harry Lee and Eliza Walker Entrepreneurship Program. The Community Foundation serves as the fiscal agent for this successful initiative.

The Walker Program was established by a coalition of area organizations in the fall of 2020 to train, fund, and support Black-owned businesses in Buena Vista, Lexington, and Rockbridge County. The grant fund provides financial support to entrepreneurs who complete a ten week training program and whose business plans are deemed viable by the Walker Program board of directors.

Grantees have six months from the time of the grant award to register their business and obtain a business license and one year to access their funds, which are held by The Community Foundation and distributed as start-up costs are incurred.

In addition, entrepreneurs in the Walker Program have access to ongoing support and assistance in various areas of their startup journey. Of particular note is their access to legal services made possible by an ongoing collaboration with students in the Washington and Lee Law School class of Prof. Carliss Chatman, a Walker Program board member. Students in the class researched trademarks, drafted operating agreements, and facilitated the filing of business formation paperwork with the state corporation commission.

In 2022, the Walker Program established headquarters at 25 W. Washington Street and hired Gabrille Cash as a part- time program coordinator. Following the most recent round of grants the program began offering continued training to Walker entrepreneurs in areas such as website creation, bookkeeping basics, social media strategies, and point of sale technologies.

Almost any charitable purpose can be served through the variety of funds offered by the Foundation. Funds can be established in your name or in the name of a loved one. Funds are managed as permanent endowments.*

Unrestricted Fund

This fund provides the best long-term flexibility to meet a broad range of important community needs as determined by the Foundation's Board.

Field-of-Interest Fund

This fund gives you the option of restricting grants to a particular charitable area of interest. Grant recipients within that field are selected by the Board.

Designated Fund

This fund allows you to choose up front a specific nonprofit organization or group of organizations to receive long-term support.

Donor-Advised Fund

This fund enables you to make recommendations each year as to grants from the fund. You can make the same or different recommendations each year.

Agency Endowment Fund

Nonprofits can establish a fund solely for their benefit within the Foundation, rather than separately creating and managing such funds themselves. Donors who are interested in helping provide significant long-term support to the named agencies are invited to contribute assets to these "open" funds at any time.

Scholarship Fund

This fund helps young women and men pursue educational opportunities.

Memorial Fund

This fund honors the memory of a loved one and perpetuates charitable issues of importance to the individual.

*Establishing an endowment fund requires a minimum of \$10,000. We enable you to create an endowment fund using a wide variety of gift techniques. There are no set-up fees, and it can be done quickly using a simple fund agreement. The Foundation does charge a modest annual charge to administer a fund and support its work in the community. We always encourage you to discuss these ideas with your attorney, accountant, or other professional advisor, as this information is not intended as legal advice.

... for Individuals or Families

- Because the Community Foundation is a 501(c)(3) charitable organization, you will receive the maximum tax advantage allowed by Federal law for your donation.
- You can provide charitable assistance to your community in perpetuity without having to worry about the day-to-day cost and burden of administration that you would experience with a private family foundation.
- You have several options for your own involvement in how your funds benefit the community, from Donor-Advised, in which you make annual recommendations regarding the distribution of funds, to Field-of-Interest, where you specify an area of interest (e.g., health, education, youth, arts), to Unrestricted, leaving decisions to the Grants Committee of the CFRBA Board.
- Your Fund will be managed by investment professionals, ensuring reasonable return on investment while protecting the principal.
- The Community Foundation can handle all correspondence related to an endowed Fund, including thank you and acknowledgment letters, if you choose to utilize this service.

... for Non-Profit Organizations

- The establishment of an endowed fund is viewed as a responsible act, demonstrating long-term commitment to an organization's mission.
- The establishment of an endowed fund at the Community Foundation ensures that there will be cash flow forever to provide for your organization.
- The fact that your board has set up such a fund helps to attract new funds because prospective donors recognize that the board is responsible for ensuring future cash flows in perpetuity.
- The establishment of an endowed fund at the Community Foundation remove the administrative burden of accounting for the funds from your organization.
- Your organization will be listed in the Community Foundation's list of Funds in the Annual Report and other publications and will be viewed by a large number of people, increasing opportunities for additional gifts to the Fund.
- Pass-through gifts are often combined with endowments, giving your organization immediate access to funds.

• CASH

You may establish a fund through an outright gift of cash. This is a simple and convenient way to give and receive tax advantages.

• PROPERTY

Some donors may also choose to contribute real or tangible property as the initial assets of the fund.

Outright Gift —

• APPRECIATED SECURITIES

Gifts of appreciated securities are particularly attractive to donors. When you transfer ownership of the securities to the Foundation, you avoid capital gain on the appreciation. The Foundation is a public charity, meaning that it qualifies for the best available treatment under current tax laws and offers full market value deductions as permitted by law.

Individual Retirement Account (IRA)

Individuals with an IRA can make a current gift of up to \$100,000 to the Foundation through a charitable rollover contribution from their IRA's assets. The donor must be $70\frac{1}{2}$ to qualify and the gift must be a direct distribution from the custodial institution. Such gifts can be counted toward the donor's annual required minimum distribution (RMD).

Bequest –

You may start a fund through a bequest in your will. Some donors designate a specific dollar amount or a percentage of their estate. Others simply leave the residue of their estate to the Foundation to create their named fund. Bequests are usually fully deductible for federal and state tax purposes. Naming the Foundation to be a full or partial beneficiary of an IRA account may provide the best tax-wise option for an estate gift.

– Life Insurance -

If you have a paid-up life insurance policy that you no longer need for your family's protection, you might consider giving it to the Foundation to establish a fund. Such a gift would qualify for an income tax deduction. If the policy is not fully paid-up, you may continue to pay the premiums and receive tax deductions for the amount of the premiums.

Charitable Remainder Trust (CRT) -

A CRT enables you to provide a lifetime income to yourself, your spouse or other beneficiary, and provide the trust principal to the Foundation at your death. This principal is then used by the Foundation to create a permanent fund named for you or a loved one to carry out your charitable wishes forever.

Private Foundation Trust

For some trustees of private foundations, the demands of administering and making grants from a foundation can become burdensome. The assets of the private foundation can be transferred to the public community foundation, and a fund carrying the same name as the private foundation would be set up. The trustee could continue to be involved with the fund as an advisor but without any of the administrative headaches. The fund would also be relieved of excise taxes and other regulations.
